

- The optimum Section teacher ratio of 1:1.5 as well as student teacher ratio of 30:1 is to be maintained to teach various subjects and school shall appoint qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board. 14
- Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class XII examinations from the year mentioned while granting affiliation/up-gradation regularly without break or inform with reasons thereof in writing well in
- Running of coaching institutions in the school premises in the pretext of providing coaching to the students for various examinations 15
- The Manger and the Principal of the school shall be jointly responsible for the authenticity of the online/offline documents/
- Apart from rules to be adhered to by the school as mentioned above for drawing specific attention of the school authorities, the school authorities are required to acquaint themselves with all the rules contained in Affiliation & Examination Bye-laws and school authorities are required to acquaint themselves with all the rules contained in Amiliation & Examination bye-laws and circulars/guidelines/notification issued by the Board from time to time. - The genuineness of information / documents / data submitted shall be of school and in case, if found otherwise the school shall
- The school shall be responsible for submission of any pending compliance, reply of show case /legal notice/ complaint and for submission of date/information sought by the Board. The extension of 05 years shall be from the date of cessation of previous
- The school is required to remit pending fee, if any
